It includes the story of how a plastic came to be developed for Toledo Scale under the leadership of the company's second president Hubert Bennett that led him to establish a separate, wholly owned company. This company, Plaskon, became the largest plastic company in the United States for a brief time. It tells of Toledo Scale's World War II contributions in which the company played a top-secret part in the production of the Norden bombsight and the atomic bomb. The story includes quotations from both retired company executives and current employees. It includes information obtained from an unpublished factual manuscript covering the company's first 50 years, other company archives and the Toledo Blade. A dozen historical photos are displayed, which include the first DeVilbiss computing scale, a Toledo Cash Register, and a Phinney scale which was the first patented computing scale. A few Phinney scales were manufactured in 1870. Since Toledo Scale couldn't locate one to prove they were actually manufactured, they lost a huge lawsuit to Dayton Scale that almost broke the company. Also shown is a photo of Norman Bel Geddes' 1929-30 radical designs of a new factory and plant campus for Toledo Scale, never built due to the depression. The story includes the transition to electronic scales begun by the company's third president Harris McIntosh. This transition was completed in the final quarter of the century. And finally, the human story that resulted from the evolution of several different ownership's is told, until just a few years ago, Toledo Scale disappeared as a separate brand and was merged into Mettler-Toledo, Inc.

Writers and painters visiting the bucolic setting could focus on their creative pursuits and find encouragement for their efforts. The most frequent visitors—considered by Cammie to be her circle of “congenial souls”—included writer/journalist Lyle Saxon, naturalist Caroline Dormon, author Ada Jack Carver, and painter Alberta Kinsey. Artists and artisans such as Harnett Kane, Roark Bradford, William Spratling, Doris Ulmann, and Sherwood Anderson also found their way to Melrose. In addition to hosting well-known guests, Henry began a collection of history books, nineteenth-century manuscripts, and scrapbooks of clippings and memorabilia that later brought her attention from the wider world. Researchers and writers contacted Henry frequently as the reputation of her library grew, and today the Cammie G. Henry Research Center at Northwestern State University houses this impressive collection that serves as a lasting tribute to Henry’s passion for the preservation of words as well as for the South’s material culture, including quilting, spinning, and gardening.

In one story, two New Jersey siblings with substance-abuse problems relapse together on Christmas Eve; in another, a young couple tries to make sense of an increasingly unhinged veterinarian who seems to be tapping, deliberately or

otherwise, into the unspoken troubles between them. In tales about characters as they age from punk shows and benders to book clubs and art museums, the promise of community acts—at least temporarily—as a stay against despair. Running throughout *Cool for America* is the characters' yearning for transcendence through art: the hope that, maybe, the perfect, or even just the good-enough sentence, can finally make things right.
